## **Vestry Meeting Minutes June 12, 2024**

- 1. Father Craig called the meeting to order at 6:30 pm and opened with prayer.
- 2. Approval of the minutes: a) Jim made the motion to approve the May 8, 2024 minutes and Gregg seconded. After discussion the Vestry suggested that the Mission committee could have speakers at their meetings and put literature about the various programs on the table in the undercroft.
